PZ/ABR Discussion: The purpose of the fence is to provide screening from the cars according to the applicant. The issue of whether the cars are permitted under the zoning code was raised and discussed but is not germane to the installation of the fence. Several Board Members would like to see something different which reflects the character of the Village rather than the proposed black fence. Mr. Mooney stated that he would build the fence of any material that the Board found acceptable. The applicant, Mr. Mooney, agreed to a solid white, 6' vinyl fence, and a picture was provided by the applicant. Joint motion to approve a solid white, 6' vinyl fence (submitted as evidence, please see Exhibit 1.0), subject to the following:

- That the fence be constructed 17 feet away from the Right-of-Way as to allow for adequate landscaping to be installed, developing the right mix of vegetation/plantings with the help of Kathy Moran, Landscape Architect, and
- 2. waiving any rights of any 'on-going' operations and/or citations, approval of the fence does not waive required compliance of all Village ordinances by the applicant or have any impact on the pending citations against the applicant, and;
- 3. the fence needs to extend along Orange Place to the distance shown on the plan and extend to the West and connect to the existing ODOT fence,
